### Note to Parents/Guardians:

The licensing authority for this program is the New Hampshire Bureau of Licensing and Certification, Childcare Licensing Unit. During visits to programs, licensing staff speak with children regarding the care they receive at a program if in the judgement of the licensing staff the children's response would be valuable in determining compliance with licensing rules. Licensing staff are experienced in working with children and trained to speak with children in a manner that is respectful and non-leading. Children will remain with their class or group during these conversations with licensing staff, and at no time will a child be forced to speak with a licensing coordinator.

➔ If a licensing staff believes your child may have specific information regarding an alleged event at the program, and determines that it is best to interview your child separately and not with their class or group, **please circle your preference from the following options:**

- a) I **give permission** for child care licensing to interview my child at the child care program separate from his/her class or group.
- b) I **wish to be notified** prior to child care licensing staff interviewing my child at the child care program separate from his/her class or group.
- c) I **do not give my permission** for child care licensing staff to interview my child at the child care program separate from his/her class or group.
